This plan is submitted with Form 3160-3, Application for Permit to Drill, covering the above described well. The purpose of this plan is to describe the location of the proposed well, the proposed construction activities and operations plan, the magnitude of the surface disturbance involved and the procedures to be followed in rehabilitating the surface after completion of the operations, so that a complete appraisal can be made of the environmental effect associated with the operations.

1. EXISTING ROADS:

Exhibit A is a portion of the BLM map showing the well and roads in the vicinity of the proposed location. The proposed wellsite is located approximately 12 miles south of Maljamar, New Mexico and the access route to the location is indicated in red and green on Exhibit A.

DIRECTIONS:

Go east of Artesia, New Mexico on Highway 82 to the Junction with Highway 529 which is past Loco Hills. Turn right on HWY 529 and go approximately 7 miles to Maljamar Road. (CR 126). Turn right on Maljamar Road and go approximately 10 miles to Dry Lake road near the Lusk Plant. At Dry Lake Road turn left here at a cattleguard and go east on existing lease road for approx. 2.2 miles to a cattleguard. Cross cattleguard and immediately to the right and go approx. 1.3 miles. Turn left here and go approx. 1.7 miles. Turn south here and go approx. 1 mile. Turn right here and go approx. 200 feet to the Lusk AIB Federal #5 well location. The Lusk AIB Federal #8H well location will be on the north side of the Lusk AIB Federal #5 and will share a portion of the Lusk AIB Federal #5 well location.

2. PLANNED ACCESS ROAD.

- A. The proposed existing access will go west of approximately 200 feet to the southeast corner of the Lusk AIB Federal #5 well location. The road will lie in an east to west direction.
- B. There will not be any new access road to this well location. Existing access will be used to access this well location
- C. The road is bladed with drainage on one side. Traffic turnouts will not be built.
- D. The route of the road is visible.
- E. Existing roads will be maintained in the same or better condition.

3. LOCATION OF EXISTING WELL

- A. There is drilling activity within a one-mile radius of the wellsite.
- B. Exhibit D shows existing wells within a one-mile radius of the proposed wellsite.

4. LOCATION OF EXISTING AND/OR PROPOSED FACILITIES

- A. There are production facilities on this lease at the present time.
- B. In the event that the well is productive, the production will be taken via pipeline to the Lusk AIB Federal #1 tank battery. The pipeline will be surface 3" SDR-11 poly line the length is undetermined at this time. Should electric power be needed for production a three phase 480 volt above ground raptor proof powerline will be built from somewhere on the side of this well south to the powerline located at the Lusk AIB Federal #5 well location. Please note attached plat showing the route of the flowline and the powerline.

5. LOCATION AND TYPE OF WATER SUPPLY:

- A. It is planned to drill the proposed well with a fresh water system. The water will be obtained from commercial sources and will be hauled to the location by truck over the existing and proposed roads shown in Exhibit A.

6. SOURCE OF CONSTRUCTION MATERIALS:

Dirt contractor will locate closest pit and obtain any permits and materials needed for construction of the well location.

7. METHODS OF HANDLING WASTE DISPOSAL:

- A. This well will be drilled with a closed loop system
- B. The closed loop system will be constructed, maintained, and closed in compliance with the State of New Mexico, Energy and Natural Resources Department, Oil Conservation Division – the "Pit Rule" 19.15.17 NMAC.
- C. Drilling fluids will be removed after drilling and completions are completed.
- D. Water produced during operations will be collected in tanks until hauled to an approved disposal system, or separate disposal application will be submitted.
- E. Oil produced during operations will be stored in tanks until sold.
- F. Current laws and regulations pertaining to the disposal of human waste will be complied with.
- G. All trash, junk, and other waste materials will be contained in trash cages or bins to prevent scattering and will be removed and deposited in an approved sanitary landfill. Burial on site is not approved.

8. ANCILLARY FACILITIES: None

9. WELLSITE LAYOUT:

- A. Exhibit C shows the relative location and dimensions of the well pad, location of the drilling equipment, pulling unit orientation and access road approach. The closed loop system will be constructed, maintained, and closed in compliance with the State of New Mexico, Energy and Natural Resources Department, Oil Conservation Division – the "Pit Rule" 19.15.17 NMAC.
- B. A 600' x 600' area has been staked and flagged.
- C. Please note a portion of the northwest corner of this location will be cut off to protect sand dunes in that area. Please note attached plat showing this.

10. PLANS FOR RESTORATION

- A. After finishing drilling and/or completion operations, all equipment and other material not needed for further operations will be removed. The location will be cleaned of all trash and junk to leave the wellsite in as aesthetically pleasing a condition as possible.
- B. Unguarded pits, if any, containing fluids will be fenced until they have dried and been leveled.
- C. If the proposed well is non-productive, all rehabilitation and/or vegetation requirements of the Bureau of Land Management will be complied with and will be accomplished as expeditiously as possible.
