
Ladies and Gentlemen:

The above referenced well(s) have been completed. Onshore Oil and Gas Order 1.XII.B Reclamation, requires earthwork for interim reclamation (See Attached Interim Reclamation Procedures) to be completed within six (6) months of well completion. If interim reclamation has been completed, submit a Sundry Notice (Form 3160-5, one original and 3 copies), Subsequent Report of Reclamation, stating that the Interim Reclamation has been completed, and is ready for an inspection.

If interim reclamation has not been completed, contact Jennifer Van Curen at 575-234-5905 within thirty (30) days to set up an onsite, to go over interim reclamation objectives to bring the well location into compliance with the Onshore Oil and Gas Order and APD Conditions of Approval.
