3. Perforate from 4754' - 4764' w/ 2 spf.
4. GIH w/ pkr to 4700' +/-.
5. Acidize w/ 750 gallons 10% NeFe.
6. Fracture treat w/ 22,000 gallons & 35,000 lbs. sand. Recover load.
7. Pull tbg & pkr.
8. Run production equip & return to production.

Returned - provide economics showing well is not producing in paying quantities. Provide additional frac details - pressures, will work string be used.
