Location size: 274x223, APD drawing 270x235, after downsize 211x212 not 175x150
Downsize as per APD: 95' north and 85' east
On the north side of the pad we could not downsize the 85' plus this was the frontage of the unit and on the east side we could not downsize the 85' due to entrance of location. The actual anchor measurements on the north are 80-81' from the edge and 79-83' on the east anchors. Therefore Apache Corporation took 81-84' off of the south edge and 19' from the west edge. This location has some erosion issues that can be corrected. Due to actual measurements, placement of anchors and wellbore the APD requirements could not be met. Please review the attached documentation for approval. The location will still need to be reseeded, but will do that during monsoon season.


