CIMAREX ENERGY COMPANY PROPOSES TO CONSTRUCT 2844.7 FT. X 30 FT. OF A BURIED, 4" FLEX LINE (150 PSI), OIL PIPELINE, FROM THE HANSON 26 FED #3 BATTERY, TO AN EXISTING PLAINS PETROLEUM PIPELINE.

THE LINE WILL BEGIN IN THE NW/4NE/4, RUN WEST, FOLLOWING LEASE ROAD, POWER LINE AND OTHER PIPELINES, THEN VEER AROUND THE #2 WELL, AND THEN WEST, ACROSS COUNTRY, AND END AT THE EXISTING PIPELINE IN THE NW/4NW/4, ALL WITHIN SECTION 26, T. 20 S., R. 34 E. PIPELINE WILL BE 2844.7 FT. (0.54 MILES) OR 1.96 ACRES.

THE LINE ROUTE IS ALL ON PRIVATE SURFACE AND THE LAND OWNER (DANNY BERRY) HAS BEEN CONTACTED AND AN AGREEMENT IS IN PLACE. THE LINE ROUTE IS OUTSIDE THE MOA AREA AND AN ARCHAEOLOGICAL REPORT WILL BE SUBMITTED TO BLM BY LONE MOUNTAIN.




