Dear Operator:

The OCD District I Office has received Bradenhead Tests results/surveys for the above referenced unit, performed in March, 2013. As a result of our review, it has come to our attention that several of the wells reported stated pressures of fluid and/or gas on the production casing. At this time the OCD District I Office is requesting the wells stated below be monitored and casing pressure reported to our office by April 30, 2013.

Please shut in bradenhead valves 24 hours prior to BHT's and give results on production casing only. If pressure has built up again equal to the pressures reported on your prior BHT Surveys (3/2013), please run a mechanical integrity test to justify the integrity of the casing.




