1. Due to compressor leakage the area has been contained to prevent on going saturation.
 2. Contaminants to the SW edge of pad have now been hauled off.
 3. All containments holding fluid have been netted.
 4. Frac tanks have been removed and all spillage has been picked up and hauled off.
 5. Unused storage containers have been removed.
 6. Bird and Bat cone is not required on compressor exhaust.
