Pre-flush w/ 30 bbls FW. Pumped stage #1 w/ 700 sx (232 bbls) of class C lead cmt & 200 sx (48 bbls). Disp w/ 343 bbls FW, bump plug @ 1350#. DV tool opened @ 480# & circ 40 bbls back to surf. Pumped stage #2 w/ 840 sx (278 bbls) of class C lead cmt & 100 sx (24 bbls) of class C tail cmt. Disp w/ 193 bbls of FW & circ 110 bbls to surf. Drilled to 9549' w/ 8 3/4" bit. RIH w/ 227 jts, 7", 29#, P-110 csg set @ 9525'. Pre-flush w/ 30 bbls FW. Pumped 310 sx (161 bbls) of class H lead cmt & 130 sx (38 bbls) of class H tail cmt. Disp w/ 352 bbls FW, did not bump plug, pumped disp 1 bbl over, full returns thru job. Drilled ahead to 14,080' w/ 6 1/8" drill bit. RIH w/ 104 jts, 28 ports, 27 pkrs, 4 1/2", 11.6#, P-110, csg set @ 14,070' & TOL @ 9209'. ND BOP NU WH. RDMO.
