Attached is a Production curve showing that when it was shut in the average production on the well was approximately 850 mcf per month. The reason the well was shut in is due to the fact that the gas purchaser, Shoreham Pipeline went out of business. The gathering system is still in place and was in working order when it was shut down. Several years ago the Shoreham system was purchased by a group who has been trying to put it back in service and start buying gas from this well again. It is my understanding that there are right of way issues with the Shoreham Pipeline and that the new owners are waiting on BLM approval to put the system back in service. As soon as the Shoreham system is back and running We plan to begin selling our gas again.
