This well is currently capable of producing economically and was doing so when it was shut in July 2008. The well was shut in because the Shoreham gathering system and plant shut down. The Shoreham plant was the only market available for the gas.

The plant is currently in the process of being re-built and the gathering system is being re-activated. I have been in contact with the new owner of the former Shoreham pipeline and they tell me that they are working on and should be able to get that line operational again. I hereby request and extension of my TA status for another year while we wait to be able to once again sell gas and oil from the lease.


