05/22/13 Move in rig up plugging equipment. ND wellhead. NU BOP. RIH w/ tbg and tag CIBP @ 4478'. Pressure up to 500 psi on casing for 10 minutes. Circulate well w/ mud laden fluid. Spot 25 sx class C cement @ 4478-4278. Pull out of cement. WOC.

05/23/13 Spot 25 sx cement @ 3380-3180. POH w/ 53 jts. Spotted 25 sx class C cement @ 1730-1530. POH w/ tbg. Perf'd csg @ 450'. Set packer at 30' and pressured up on casing to 1700 psi. RIH open ended to 500' and spotted 50 sx class C cement to surface. ND BOP.

05/24/13 rogged dpwn rig and moved off. Moved in welder and helper. Cut off wellhead. Welded on Above Ground Dry Hole Marker. Backfilled cellar. cut off and removed deadmen. Clean location moved off.
