13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. A 2" hammer union was not tightened after loosening the union in order to make repairs. The Lease Operator arrived the following day and found that the hammer union was leaking and proceeded to shut in the well. Crews were called back to the area in order to repair leaking flowline and begin cleanup. Approximately 3 bbls of total fluid was spilled consisting of 2.5 bbls of production water and a 0.5 bbl of oil. Approximately 2 bbls of produced water and .5 bbls of oil were recovered. Impacted soil was excavated and stockpiled on site. All impacted soil will be transported to an approved disposal facility. Confirmational soil samples were collected and analyzed for Chlorides.
