OXY USA WTP LP respectfully requests a 1 year extension on the temporary abandonment status of this well for further evaluation of the waterflood unit. OXY has begun implementing a project that includes revitalizing the northern (active) portion of the unit and testing potential in the southern (inactive) portion of the unit. The project entails drilling 4 new wells, all of which have been drilled and the completions are currently scheduled for June. These wells will decrease the primary production spacing from 40 acre to 20 acre spacing. Along with the newly drilled wells, the wells in the immediately surrounding area will be worked over. There will be 5 producing wells re-stimulated with more appropriate completions for the reservoir and 5 injection wells will be cleaned out and stimulated to ensure sufficient flooding. In the South portion of the field, Oxy has identified 4 test wells to recomplate in new zones and evaluate the potential of the inactive portion of the field. From the results of the project, Oxy will evaluate and determine the potential for reactivation of this well.
