Legacy Reserves Operating LP requests approval for a short continuance of temporary abandonment status of the subject well for a period of 6 additional months. Presently, the current approved temporary abandonment is set to expire on June 20, 2013.

We pressure tested the subject well on 4/26/13 to a test pressure of 512# psig for 30 minutes and the casing tested successfully. Chart attached.

We are again evaluating this and other temporary abandoned wells on this unit and anticipate starting field operations within the next 60-90 days to either re-activate or PXA this well.
