ConocoPhillips will utilize 3", 2500 lb, fiberglass line buried according to BLM rules. A 15' construction corridor will be needed to bury approximately 500' of line. Enclosed are the following supporting documents.

 - Overview map of new facilities/injection lines.
 - Well specific map for MCA #449
 - Cross section of trench for burying the line.
 - Survey Plat of Proposed Pipeline
- This well is expected to be completed in April 2013.


