7/9/13 to 7/10/13 - Drill out cement. Test csg to 1100 psi (chart enclosed) witnessed by Ms. Pat Hutchins.


7/11/13 - Drill out CIBP @ 4300'.

7/17/13 - TIH w/138 jts 2 3/8' 4.7 lb/ft EUE Salt liked tbg and P.I. Arrow set pkr @ 4313'. Tested csg annulus to 680 psi for 30 minutes.

**Operator is required to submit a NOI Sundry to change to name of the well Back to E-K Queen Unit 619.**

**Operator also required to submit a Completion Report Form 3160-4 showing well as a water injection well.**
