Legacy Reserves Operating LP recently purchased the Langlie Jal Unit and took over as operator on June 3, 2013. Legacy is currently in the process of evaluating this well for reactivation potential. All available data is currently being compiled and will be evaluated to determine if it is economically justifiable to drill out the temporary plug, equip this well with lift equipment, and return it to production. If it is determined that it is not economic to do this work, the well will be plugged and abandoned.

*Well has been shut-in since Jan 1997. Operator will be given 60 days to determine their plan or submit P&A. (October 21, 2013).*
