ConocoPhillips Company respectfully request to modify the existing approval pertaining to the route of the proposed power line. As indicated by the attached plat, it is our intent to bring the power off the NW corner of the approved pad site and head west to the Xcel power system. The distance of this modification is approximately 597' which would consist of no more than 3 power poles. Additionally, the power line will travel the approved utility corridor already established for the pipeline(s) to the Buck CTB as indicated on the additional map. The power line and pipeline will be in the same corridor already analyzed and authorized.






