WE WOULD ALSO INCREASE THE CEMENT VOLUME FROM 360 SACKS TO 800 SACKS TO PLUG BACK THE PILOT HOLE TO THE KICK OFF POINT OF THE HORIZONTAL LATERAL IN THE 3RD BONE SPRINGS.

*To achieve plug back to ROP requires 855 sacks at 1.05 yield. - no excess included. More cement required.*
