08/13/13 MIRU plugging equipment. Dug out cellar. ND wellhead, NU BOP. Released packer and POH w/ tbg and packer.

08/14/13 Rigged up wireline and RIH w/ gauge ring to 4825'. RIH w/ 5 1/2 CIBP and set @ 4800'. Set BP and circulated hole w/ mud laden fluid. Spotted 25 sx cement @ 4800-4547. Pulled out of cement.

08/15/13 Pressure tested casing to 500 psi. Bled of pressure. Tagged plug @ 4563'. Perf'd csg @ 4270'. Pressured up on csg to 500 psi. RIH w/ tbg to 4320 and spotted 60 sx cement @ 4320-3931. POH to 2600'. WOC. Tagged plug @ 3927'. Spotted 50 sx cement @ 2600-2448. POH w/ tbg. WOC.

08/16/13 Tagged plug @ 2440'. Perf'd csg @ 436'. Got injection rate of 1/2 bbl/min @ 600 psi. Sqz'd 80 sx cement and displaced to 336'. WOC. Tagged plug @ 318'. ND BOP and wellhead and spotted 25 sx cement @ 60' to surface. Rigged down and moved off.

08/19/13 Dug out cellar and cut off wellhead. Welded on a 12.5 inch plate Dry Hole Marker 3 feet below ground. Back fill cellar. Cut off deadmen and cleaned location. Moved off.
