CIMAREX ENERGY COMPANY IS REQUESTING TO CONSTRUCT 1170.9 FT. OF TWO, BURIED 4" FLEX PIPE GAS PIPELINES (900 PSI). THE ONE LINE WILL TAKE THE GAS FROM THE TRISTE DRAW 30 FEDERAL #1H BATTERY (SW/4SW/4 SEC. 30, T. 23 S., R. 33 E.), WEST, FOLLOWING THE ACCESS ROAD, TO THE SALES LINE (DCP) AND METER AT THE TRISTE DRAW 25 FEDERAL #1 (SE/4SE/4 SEC. 25, T. 23 S., R. 32 E.). THE SECOND LINE WILL BE A BURIED, BUY BACK GAS PIPELINE OF 4" FLEX PIPE, (900 PSI) TO RUN 1170.9 FT. FROM THE SAME DCP LINE AT THE TRISTE DRAW 25 FED #1, EAST, FOLLOWING THE ACCESS ROAD AND ADJACENT TO THE SALES LINE, TO THE TRISTE DRAW 30 FEDERAL #1 BATTERY, TO BE USED, AS NEEDED, FOR POWER TO OPERATE THE TRISTE DRAW 30 FEDERAL LEASE WELLS (#1, #2, #3).

A ROW HAS BEEN FILED FOR THE BLM SURFACE PORTION OF THIS LINE SYSTEM IN SECTION 25, WHICH IS A DIFFERENT LEASE, AND THIS SUNDRY APPLICATION IS FOR THE PRIVATE SURFACE PORTION. THE LEASE IN SECTION 25 IS LC-063228 AND NM-031224 IN SECTION 30.

THE PROPOSED PROJECT IS ALL WITHIN THE ARCHAEOLOGICAL CLEARED AREA FOR THE ACCESS ROAD SYSTEM. CONSTRUCTION WILL BEGIN UPON APPROVAL AND WILL TAKE ABOUT 15 DAYS TO COMPLETE.

THE LAND OWNER IN THE SW/4 OF SECTION 30 IS BRININSTOOL XL RANCH (CHRIS BRININSTOOL) WHOM CIMAREX ENERGY COMPANY HAS AN AGREEMENT IN PLACE FOR THE TRISTE DRAW FEDERAL WELLS, ROADS, AND UTILITY LINES.


