Cement: Lead 400sx VersaCem-PBSH2 + .5pps LAP-2 + .25 lbm/sk D-AIR 5000 + .2% HR-601 (13.2ppg, 1.59 ft3/sk slurry yield, 8.29 gal/sx wtr)

TOC: 10,850' (top of liner) *Contact BLM if TOC is not achieved.*
