Caza Operating, LLC request permission for a variance to the approved APD in order to more completely evaluate the 3rd Bone Spring target zone. Caza proposes to drill a vertical 8-3/4" pilot hole to ± 12,000' MD. At this point we will run a gyro, run electric logs & take sidewall cores. The operator will then plug back the well using ± 500 sks class "H" cmt mixed @ 15.6 ppg. Cement will be dressed to KOP. Operator will set an oriented open hole whipstock and drill the 8-3/4" curve/lateral as per the original APD.
