ConocoPhillips respectfully submits this subsequent report of spud and surface casing for this well.

Well was spud 10/18/13 with 12-1/4" bit. Drilled to 1068'. Set 8-5/8" 26 JTS, 24#, J-55, ST&C casing with shoe at 1052'. Pumped 20 bbl spacer. Cemented with 400 sx (124 BBLS) lead class C cement(1.75 yield) 13.5 PPG. Followed by 250 sx(60 BBLS) tail class C cement(1.34 YIELD) 14.8 PPG. Dropped and dislaced with 65 BBLS freshwater. Bumped plug 500 - 1100 PSI AT 1730 HRS. Circulated 75 bbl cement to surface.

WOC.Test casing to 1500 psi. Drilled out to 1078' to FIT. EMW 14.8 ppg.
