Proposal: Set 50 sx cement plug 385' - 460'. Set 90 sx plug 225-360'/Tag. Set 10 sx plug 0-30'. Install dry hole marker. Hole will be loaded with 10# mud, and the plugs will be displaced with 10# mud. **60' to surface**
