

On November 22, 2011 a letter was sent to the Carlsbad BLM office to provided surface owner notification concerning the proposed closure of the drilling reserve pit. On April 16, 2012 the site was re-seeded with 46 lbs of BLM Mix No. 2 seed. Prior to seeding the area was disked, then seeded, followed by a final disking to provide the best opportunity for seed germination. Weather on the day of seeding was clear, approximately 70° F, with light winds. Photographs that document the seeding activity are provided as an attachment.






Initial Disking of Site
