\*Trip in hole with 2-78" tubing with turned down and beveled couplings to 9150'. POOH.

\*Rig up WL truck, pick up CIBP, TIH and set @ 9150'. Dump 10' of cement.

\*Pick up 3-1/8" perforating gun loaded 4 SPF, PERFORATE:

8480-8487    8647-8652    8877-8880

\*TIH and set Packer @ 8350'. Test backside to 500#. Pump 5000 gallons (320 Gallons P/FT) of 15% acid with additives and drop 65 Bio Balls at a rate of 10-12 BPM, 4500 psi max.

\*Swab well and test.

**Notes:**

- 1. Operator was issued a 60 day letter on this lease in April 11, 2012.**
- 2. Operator submitted sundries to perform work.**
- 3. Operator was to commence work by May 31, 2012.**
- 4. Operator submitted a Subsequent Report October 8, 2012 stating that they had returned the well to production. Operator was required to submit economics that the well was producing in paying quantities. Operator has not submitted that to date. Therefore, they are in non-compliance.**
- 5. Operator then sent in a sundry on 12/11/2012 stating that they planned to move in on the well on 12/10/2012. This was submitted as a subsequent report, which implies that the work has been completed. That sundry listed perforations in the Wolfcamp.**
- 6. Then the operator submitted a sundry on December 20, 2012 to indicate that the well was on production but did not provide any dates. A subsequent report is required to show the dates that actions occurred. Since this sundry came in after the subsequent report for the re-completion to the Wolfcamp, it implied that the work had been performed.**
- 7. The production figures do not match what was submitted to NMOCD. Also, the BLM shows no production reports after April 2013, but NMOCD has reports through September 2013.**

**Operator is to provide a detailed account of the operations by date for this well since May 31, 2012. The operator is in non-compliance on this well as they did not provide the economics requested over a year ago.**

**Operator shall address the above concerns by February 15, 2014.**
