Subject well was fracture treated with 55,000 gals of liquid propane and 40,000 lbs of 18/40 Versaprop proppant during 2012. Since that time, withdrawal operations were ceased due to excessive proppant in 8" x 1.04 mile flow line. Operator proposes to flow back well during week of February 3, 2014 to clean up well bore and perforations and place the well back into full injection/withdrawal service.
