11-12-2013 Drilled 17-1/2" hole to 1287'. Run 10 joints (1291.4') 54.5# J-55 ST&C and 20 joints 48# J-55 ST&C casing set at 1287'. Cement Lead: 800 sacks Extend A cement Class C 13.7 wt, 1.67 yield. Tail 550 sacks HalCem 14.8 wt, 1.33 yield. Displace with 195.1 bbls. H2O. Did not circulate cement to surface. WOC. Run Temperature Survey, TOC 340'. Pick up 1" pipe, tagged cement at 170'. Fill annulus from 170' with 4 bbls. fresh water spacer and 152 sacks HalCem C neat 14.8 wt, 1.33 yield. Circulated 5 bbls. to surface.

11-18-2013 Drill to 5103'. Run 65 joints 9-5/8" 40# HCL-80 and 61 joints 40# J-55 casing set at 5103'. Cement Lead: 1400 sacks EconoCem HCL 12.9 wt, 1.85 yield. Tail: 300 sacks HalCem 14.8 wt, 1.33 yield. Displaced with 384 gals. Circulated 515 sacks cement to surface.
