11/28-12/14/2013: Drill 8-3/4" hole to 10,955'. Run 7" 26# HCP-110 LTC csg to 10,916'. Cmt w/500sx Tuned Light lead, 250sx Versacem tail. WOC. Cut csg, test to 3000psi.

12/15-12/24/2013: Drill 6-1/8" hole to 15,254'. Run 4-1/2" 11.6# P-110 Buttress liner fr/10,408-15,242' w/28 Optiport sleeves. Cmt w/400sx Versacem cmt, circ 45bbbls to 2860' (per CEL). NU tbg head, test. Release rig 12/24/2013.
