



WATER PRODUCTION & DISPOSAL INFORMATION

In order to process your disposal request, the following information must be completed:

1. Name of formations producing water on the lease. Bone Springs

2. Amount of water produced from all formations in barrels per day. 130 BPD

3. Attach a current water analysis of produced water from all zones showing at least the total dissolved solids, ph, and the concentrations of chlorides and sulfates. (One sample will suffice if water is commingled.)
4. How water is stored on lease. 2-500 bbl fiberglass tanks
5. How water is moved to the disposal facility. Transfer
6. Identify the Disposal Facility by:
 - A. Facility Operators name. Newbourne Oil Company
 - B. Name of facility or well name and number. QPBSSU Facility
 - C. Type of facility or well (WDW) (WIW) etc. WIW
 - D. Location by 1/4 1/4 SESW Section Sec 23 Township 18S Range 32E
7. Attach a copy of the State issued permit for the Disposal Facility.
