2/21/14 - NDWH & NUBOP. Test down tbg-csg annulus w/ 500# for 10 mins and held ok. Release pkr & TOH w/ 92 jts of IPC tbg + 2' sub with AS1-X pkr. Pkr rubbers were swollen. Change out pkrs. TIH w/ 92 jts of 2 3/8" tbg & 1-2' x 2/38" sub, 4.7#, 8rd, EUE, J-55 regular TDC IPC tbg. Ran pkr to 2992'. Ran preliminary test to 500# and held ok. Release on/off tool from pkr and circ pkr fluid. NDBOP & NUWH. Ran 30 min MIT. Lost 80# in 30 min. Tested twice with same results. Remove 2' x 2 3/8" IPC tbg sub and set pkr from 2990' to 2996' with 10 points of tension. Ran MIT for 30 min and held 500# with no psi loss.

2/24/14 - Called Maxie Brown w/ OCD. Ran MIT. Tested 30 mins; start pressure = 535# & end pressure = 530#. Copy of chart is attached. Connect to injection.
