- 1) RUPU. Kill well w/ 2% KCl. POOH w/ rods & pump. NU BOP. POH w/ tubing.
- 2) RU WL. RIH w/ casing gun, perf 5116-20', 5124-5132', and 5134-42' w/ 4 jspf (80 holes total). RD wireline.
- 3) RIH w 5 1/2" RBP w/ ball catcher and packer, set RBP @ +5180'. Set pkr @ 5170', test RBP to 1000#. Unset pkr, spot 150 gals 15% NEFE. Pull packer to +5070', reverse acid into tubing, and set packer. Test casing-tubing annulus to 500#. Put acid away. Swab and test Paddock 5116-5142'.
- 4) Acdz w/ 3500 gal. 15% NEFE and 160 1.1 SG RCNBs. Swab back load and test.
- 5) Unset pkr, POH.
- 6) RIH w/ tubing, rods, and pump. Hang well on.
