1) RUPU. Kill well w/ 2% KCl. POH w/ rods & pump. NU BOP. POH w/ tubing.

2) RU wireline. RIH w/ casing gun, perforate 5093-97', 5100-10', 5114-5124', and 5126-42' w/ 4 jsf (160 holes total). RD wireline.

3) RIH w 5 1/2" RBP w/ ball catcher and packer, set RBP @ +5200'. Set pkr @ 5190', test RBP to 1000#. Unset pkr, spot 150 gals 15% NEFE @ +5142'. Pull packer to +5043', reverse acid into tubing, and set packer. Test casing-tubing annulus to 500#. Put acid away. Swab and test Paddock 5093-5142'.

4) RU acidizers. Acidize w/ 3500 gals 15% NEFE and 320 1.1 SG RCNBs. Swab back load and test.


5) Unset pkr, POH.

6) RIH w/ tubing, rods, and pump. Hang well on.
