- 1) Rig up Coiling Tubing Unit with Perf Clean Tool
 - 2) TIH to 4242'
 - 3) Run perf clean tool with water across perforations 4120-4198'.
 - 4) Close backside and repeat perf wash from 4120-4198' with 2500 gals 15% NEFE HCL
 - 5) Pump 10 bbls gel sweep to bring fines to the surface
 - 6) POOH with CT and RD Coil Tubing Unit
 - 7) Return well to injection
- During this procedure we plan to use the closed-loop system with a steel tank and haul contents to the required disposal per ODC Rule 19.15.17
