

Above ground steel tanks will be used to collect and manage all fluids during the drilling process.


Operations and Maintenance Plan

The approved drilling contractor will supply, operate and maintain all steel tanks used during the drilling operation. Daily inspections of the tanks will be made to insure that no leaks or spills occur. Should a leak or spill occur, all operations will be halted until the NMOCD is notified and the source of the leak or spill is isolated and repaired. Any contaminated soil or liquids will be dealt with in accordance with NMOCD rules.

Closure Plan

After drilling operations are completed, all fluids and solids will be removed from the steel tanks and disposed of at Parabo "Sundance" disposal facility (permit number: NM 01-0003) which is 3 miles east of Eunice, NM. If this site is not available for disposal, another NMOCD approved facility will be utilized.
