Pressure tested csg and held 500 psi. Perf'd csg @ 1310'. Pressured up on perms. Spotted 50 sx cement @ 1360-878, (per Patricia Hutchings w/BLM).
05/08/14 Tagged plug @ 840'. Perf'd csg @ 350'. Pressured up on perms to 600 psi. Spotted 45 sx cement @ 400' to surface. RDMO.
05/12/14 Moved in backhoe and welder. Cut off wellhead and welded on "Below Ground Dry Hole Marker". Backfilled cellar. Cut off and removed deadmen. Cleaned location and moved off.
