Conditions of Approval (COAs)

1. All oil sales will be conducted as per Onshore Order #4, III, B, C & D. The use of Tank Logix system for the sales of oil is not approved. The use of Tank Logix system for daily pumpers reading is approved.
2. The installation of Tank Logix system is **not** approved if it affects the tank integrity in any way. Tank equipment shall be installed and maintained as per Onshore Order #4, III, C, 1 (*Sales Tank Equipment*) and API requirements. The installation of this system must not prevent the oil storage system from holding Pressure/Vacuum.
3. Upon completion of installation of this system and within 30 days a Subsequent Report will be required on a Sundry Notice form (3160-5) and an inspection by BLM will take place prior to final approval of this system.
