

 05/31/2012 POOH and lay down Bit and Scrapper and Rig up wireline and log truck and run Micro Vertilog, Reservoir Performance Monitor PNC 3D.
 06/01/2012 Pump 400 bbl of fresh water and start run log.
 06/04/2012 Set plug above Perf, pump 120 bbl of fresh water and run Cement Bond log and CPN log. Rig down wireline and log truck.
 06/05/2012 TIH with 318 JTS. 2 3/8" tubing and POOH with 2 3/8" tubing No plug TIH tubing.
 06/06/2012 Pump 100 bbls Circulate sand and fish plug. Release plug POOH 318 JTS. 2 3/8" lay down plug.
 06/07/2012 Run Production tubing:
 1 JT. MUD Anchor with bull plug.
 4' Perf SUB
 2 3/8" SN
 326 JTS. 2 3/8"
 06/07/2013 Swab the well and put the well beck on production.


