ConocoPhillips Company respectfully submits this subsequent report of Sundry Operations.

History-

ConocoPhillips Co. originally drilled this well beginning February 1, 2014. While cementing the production casing, of a two string design, we did not circulate cement to surface as planned. We performed diagnostic tests as requested by BLM representatives and submitted the results. On March 7, 2014 we completed an approved remedial operation to perform a bradenhead squeeze down the annulus. We cemented across an open hole section and had good cement into the surface casing shoe. Requested tests were again performed and submitted. However, we were not able to complete a satisfactory MIT. Remedial operations were performed using Liquid Bridge Plug technology. Subsequent reports were submitted and concurrence to proceed with completion operations was given.



On May 29, 2014, the annulus was again pressure tested, in accordance with Condition of Approval #6 and deemed acceptable by BLM witness Ms. Hutchins. Attached please find the Ruby Federal #33 pressure chart.
