Spud 14-3/4" hole 6/11/14, drill to 1216', 6/11/14. RIH & set 11-3/4" 47# J-55 BTC csg @ 1216', pump 30BFW spacer w/ red dye, then cmt w/ 510sx (157bbl) PPC w/ additives 13.5ppg 1.74 yield followed by 250sx (60bbl) PPC w/ additives 14.8ppg 1.34 yield, had full returns, circ 387sx (120bbl) cmt to surface. RU BOP, test @ 250# low 5000# high. 6/13/14, RIH & tag cmt @ 1150', test csg to 2150# for 30min, test passed. Drill new formation to 1226', perform FIT test to 151psi, EMW=12.3ppg.

6/13/14 drill 10-5/8" hole to 5080', 6/15/14. RIH & set 8-5/8" 32# J55 LTC csg @ 5075', pump 30bbl gel spacer then cmt w/ 1750sx (577bbl) Light PPC w/ additives 12.9ppg 1.84 yield followed by 360sx (85bbl) PPC w/ additives 14.8ppg 1.32 yield, had good to partial returns during displacement, circ 1031sx (340bbl) cmt to surface, WOC. Install Cameron pack-off bushing, test to 5000# for 15min, good test. 6/16/14, RIH & tag cmt @ 5021', circ hole, pressure test csg to 2750#, balanced out @ 2738#, held for 30 min, tested good. Drill new formation to 5090', perform FIT test w/ to 635psi EMW=11.9ppg. bled to 369psi EMW=10.1 in 5 min.
