After further discussion with Bill Sonnamaker, some items of concern need to be clarified before we approve any work performed on the DHM at this well. Bill gave me an api # 30-025-07625. Plugged well release of 8/22/2000. After reviewing pictures of the area surrounding the location, there may be a question as to the land ownership.

According to records, this location is on Patent land (fee owned). Any cutting of the dry hole marker **may** require the approval of the land owner and OCD before any modifications to the existing marker are performed.

We will forward this information to Maxey Brown, when he returns on Monday, June 30, 2014. He will be able to answer your question possibly at that time.
