- We will drill out from intermediate with an 8-3/4" hole size to pilot hole TD.
- * PHTD = 12,600'
- * Will plug back with 3 stacked plugs of the following:
- * Plug #1: 850' F/11,750' - 12,600' (375 sx of 17.2# 0.98 cf/sk Class H)
- * Plug #2: 850' F/10,900' - 11,750' (375 sx of 17.2# 0.98 cf/sk Class H)
- * Plug #3: 800' F/10,100' - 10,900' (350 sx of 17.2# 0.98 cf/sk Class H)
- * We will drill an 8-3/4" curve.
- * After landing curve we will reduce hole size to 7-7/8" and drill the lateral to planned TD +/-15,440 MD/10,850' TVD.
