Drilled 8-3/4" hole to a final total depth of 12,423'. Reached TD on 07/04/2014. Ran a full suite of open hole logs. Ran 7", 26#, HC-P110, LTC casing and set at 12,332'. DV tool at 8,250'. Set packer shoe and cemented first stage with 350 sacks 50/50 H Poz + 10% Bentonite + 3# Kol-seal + 0.125# cello-Flake + .3% retarder (11.8 ppg; yld 2.30 cuft/sk) and 240 sacks 50/50 H Poz + 2% Bentonite + 5% Salt (14.4 ppg, Yield 1.26). Opened DV tool and cemented second stage with 410 sacks 50/50 H Poz + 10% Bentonite + 3# Kol-seal + 0.125# cello-Flake + 5% Salt (11.8 ppg; yld 2.45 cuft/sk) and 200 sacks Class H neat cement (mixed at 15.6 ppg; yld 1.18 cuft/sk). Nipped-down BOP's and set casing slips. Released drilling rig on 07/14/2014.
