- RU Pulling unit. Pull rods and pump, if any, and LD same.
- Install BOP. Pull and visual inspect tubing.
- TIH w bit and scraper to 100' above the perfs (4452-4523').
- TIH with CIBP and set same 90' above the perfs. TAG same.
- Pull above the CIBP and circulate hole with 10# gelled brine and spot 25 sxs cement plug on top of CIBP.
- If necessary, perf and squeeze 25 sxs cement at top of the salt (circulation show cement above salt top). BLM directive needed.
- Perf squeeze hole at base of 8 5/8" (365') and squeeze 35 sxs cement. WOC and TAG same.
- Set 10 sxs surface plug. Cut off well head. Install DH marker. RD and cut off anchors. Clean location to the satisfaction of surface owner and BLM.
