2. The caliche from the location will be removed. The location will be cut, ripped, cross-ripped and then windrows will be installed.
4. The soil lift will be contoured to match the surrounding terrain and the location will be seeded using the recommended BLM LPC seed mix for the area.
4. The caliche will be used as a road closure berm to prevent access to the location.
