11/25/2013 Run 112jts of 8 5/8" 32.0#/ft K-55 STC casing to setting depth of 4409'. Rig up Halliburton and cement with 1400sx EconoCem-HCL w/2.0% Econolite + 5#/sk salt + 5#/sk KolSeal + 0.125#/sk Poly-E-Flake (weight=12.5#/gl, yield=2.11cf/sk) & tail in with 400sx HalCem-C Neat (weight=14.8#/gl, Yield=1.33cf/sk). Plug down @ 10:30pm. Circulated 252sx (100bbbls) to surface.

11/26 & 27/2013 WOC 12hrs before cutting off wellhead, Dress off 8 5/8" casing & nipple up "B" section of casing head, Nipple up & test BOPE, Wait total of 24 hours before picking up bit as per BLM Potash Area requirement, Pick up 8.75" bit w/directional tools & trip in hole to top of cement @ 4369', Start drilling on cement @ 1:30am on 11/27/2013, Start drilling new formation in 7.875" hole @ 5:30am on 11/27/2013.
