RU and POOH with production equipment, make cleanout run with bit and casing scraper. Set composite bridge plug at 3865. Perforate squeeze holes at 3820-3821. RIH and set cement retainer at 3810, Pumped 360 sx class C w/2% CACL at 4 bpm @ 1487 psi. Wait 24hrs of cmt, Pu bit and drill out cmt retainer and cleanout well. Pressure test squeeze to 500 psi, good test. RU WL and ran cmt bond log form 3540-2480, good cmt to 2645, RIH with CBP and set at 3800. Perforate Grayburg 3660-3670, 3780-3790 with 2 spf, 120 phasing, 40 shots. Pump 4000 gals 15% NEFE acid to breakdown new perforations. Frac well with 89,260 lbs of propant. Put well back of production.
