Devon Energy Production Company, L.P. respectfully requests a variance to the approved cementing plan for the 5-1/2" production string on the Fighting Okra 18 Fed Com 1H. A casing bond log was run to confirm TOC. The CBL showed TOC to meet the conditions of approval, but showed poor cement bond below the TOC. No pressure changes were detected during frac operations and an MIT was performed and passed on the annulus after the frac. Per Denise Menoud, the field office has provided a copy of the MIT chart to Paul Swartz.

Sundry is DENIED. There is no BLM documentation of the mentioned MIT. Rerun the test.
