BTA Oil Producers LLC planned to temporarily alter the wellbore for this well, perform microseismic work, and return the wellbore to the production configuration. However, our freepoint was higher than anticipated and the microseismic work was cancelled.

We are currently swabbing the well back to return to production.

The reservoir study, as a COA for the permission to perform the microseismic, is being prepared and will be submitted to the BLM, when completed. As the remaining proposed work was not performed within the wellbore, no CBL was run nor pressure test taken.
